### 3 Composition/information on ingredients

Chemical characterization

Description: Mixture of substances listed below with nonhazardous additions.

Tung Oil, PB Linseed Oil, Colophony, Pine Resin, Carnauba Wax, Beeswax, Citrus Oil, Isoparafin, Manganese, Cobalt and Zirconium driers.

### 4 First aid measures
